NOTICE TO RESPONDENTS

Remedy claimed or sought:

1. The Applicant/Defendant, Mile Two Church Inc. ("**Mile Two**") applies for the following relief:
 - a. An Order pursuant to Rule 3-71 of *The King's Bench Rules* requiring the Respondents/Plaintiffs, Caitlin Erickson, Jennifer Soucy (Beaudry), and Stefanie Hutchinson (together, the "**Plaintiffs**"), to provide further and better responses to certain particulars requested by Mile Two in its Request for Particulars dated October 30, 2023 ("**Mile Two Request**") that are identified in **Schedule "A"** to this Notice of Application within 60 days of the date of the Order; and
 - b. An Order granting Mile Two the costs of this application.

Grounds for making this application:

2. Mile Two delivered the Mile Two Request pursuant to the September 15, 2023 Order of the Honourable Justice N. Bardai (the "**September 15 Order**"). The Mile Two Request concerns the Second Amended Statement of Claim dated June 29, 2023 (the "**Claim**").
3. In response to the Mile Two Request, the Plaintiffs delivered a Reply to Request for Particulars dated December 28, 2023 (the "**Reply to Mile Two**").
4. The Reply to Mile Two is deficient. Accordingly, Mile Two seeks an Order directing the Plaintiffs to provide it with further and better particulars to certain requests identified in **Schedule "A"** to this Notice of Application.
5. The unique position of Mile Two amongst the Defendants to the within Action impacts the scope of particulars to which it is entitled. The Claim sets out allegations for which Mile Two is alleged to be principally liable. The Claim also asserts that Mile Two is vicariously liable for the actions of other Defendants as well as unnamed individuals.
6. Mile Two is entitled to know the case against it. A key function of a statement of claim is to alert defendants to the case they are required to meet. The Claim does not alert Mile Two to the case that it must meet. Further, the Reply to Mile Two does not provide Mile Two with particulars that it requires to understand the case against it.
7. Mile Two is also entitled to particulars pertaining to the suitability of the within Action as a

class action. In this regard, Mile Two is entitled to particulars that inform the certification criteria set out in s. 6(1) of *The Class Actions Act*, SS 2001, c C-12.01.
