AFFIDAVIT OF CAITLIN ERICKSON

I, Caitlin Erickson, of the Town of Leask, in the Province of Saskatchewan, MAKE OATH AND SAY:

- I am a Plaintiff in this action and have personal knowledge of the facts attested to herein, except where stated to be on information and belief, and where so stated I verily believe the same to be true.
- 2. I am advised by my solicitor, Samuel W. Edmondson, and believe to be true, that:
 - (a) A freedom of information request was made to the Ministry of Education (the "FOI Request") and sent by courier on August 11, 2022. A true copy of the said request and cover letter are attached hereto as Exhibit "A".
 - (b) A request for review was made to the Information and Privacy Commissioner, which concluded with the Information and Privacy

- Commissioner rendering Review Report 247-2022, indexed on CanLII as (Saskatchewan Education) (Re), 2023 CanLII 26218.
- (c) Between October 14, 2022 and March 25, 2024 the Ministry of Education delivered, by electronic means, 31 batches of records, along with cover letters, in relation to the FOI Request. The records produced by the Ministry include redaction, purporting to be on grounds pursuant to *The Freedom of Information and Protection of Privacy Act*.
- (d) The Ministry advised, by letter dated March 28, 2024, that it had concluded its production of records in response to the FOI Request. A true copy of the said letter is attached hereto as **Exhibit "B"**.
- (e) A request for review was made, with respect to whether the Ministry had appropriately applied various section of *The Freedom of Information and Protection of Privacy Act* (the "Substantive Review"). A true copy of the Substantive Review is attached hereto as Exhibit "C". Accompanying the Substantive Review, a letter detailing the basis for the review was sent to the Information and Privacy Commissioner on April 11, 2024, a true copy of which, excluding the enclosures and USB key referenced therein, is attached hereto as Exhibit "D". The referenced enclosures and redacted productions are approximately 1.38GB of files, consisting of in excess of 9,000 pages of productions and correspondence, and have been omitted from this Affidavit but can be filed if requested by the Court.
- (f) Many of the redactions by the Minister in its production of records in response to the FOI Request are the name or e-mail address of personnel of Mile Two Church Inc., or its predecessor, and the name and other details of individuals for whom the Ministry granted a license or certificate to teach at Legacy Christian Academy, or its predecessor. It is these redactions which form the basis for the Substantive Review.

3. I attended a meeting with Minister Dustin Duncan and Deputy Minister Donna Johnson on September 21, 2022. In the course of that meeting, the Minister committed to prioritizing responding to the FOI Request and confirmed that the Ministry would not charge fees for responding to the FOI Request.

RE: Your Access to Information Request Number ED10-22G

Thank you for your access to information request received on August 16, 2022, requesting access to:

"All records relating to the school operated by Mile Two Church Inc., formerly Saskatoon Christian Centre Inc., (Legacy Christian Academy, formerly Christian Centre Academy) including but not limited to records relating to licensing; funding; registration and approval as an independent school; teachers at the school(s) operated by Mile Two Church Inc., or its predecessors, accredited or for whom a waiver has been provided; and all complaints or reports made in relation to the school, the associated church, and their respective staff [between 1982 and August 15, 2022]."

On March 25, 2024, the Ministry of Education [Ministry] released the final package of records related to your request. In total, 9,027 pages have been released to you, in full or in part. This number is considerably less than the Ministry's original page estimate for your request. As such, I write to provide some context for the difference.

In general terms, it was difficult to provide an accurate page estimate for your request due to the size of this file, the number of records, and the original format of records that pre-date 2000. More particularly, the pre-2000 records were originally in paper format and required scanning to prepare them for review and redaction.

In lay terms, scanning paper files creates an electronic image of the document, which is saved in Portable Document Format or .pdf. The conversion of paper documents to .pdf can create very large electronic file sizes, which is what happened here.

Page count estimates for access to information requests are generally based on the electronic file size(s) of the assembled records before the records are reviewed and actual page counts can be accurately tabulated. Where, as here, significant numbers of paper documents are converted into large .pdf files, the estimated page count can unintentionally be inflated as a result.

In addition, numerous spreadsheets are included in the responsive records for your request. Spreadsheets typically contain embedded calculations and formulas that cause their electronic file sizes to become quite large. When those documents are converted to .pdf, their size in megabytes is often significant. This also caused the number of estimated pages for your request to be unintentionally inflated.

I can also advise that when the Ministry processed the last package of scanned documents for your request, we realized that there were no documents that pre-date 1989. My staff conducted a secondary review of documents in storage, and no additional records were located. Therefore, I can advise that the Ministry has no records from 1982 to 1988.

It is my understanding (although I am certainly no expert) that private schools were not registered with the then Department of Education until 1989. This may help explain why the Ministry does not have any records from 1982 to 1988.

The Ministry understands that previous communications indicated far more records than have been released in response to your request. As noted, these communications were based on initial and erroneous page estimates. We apologize for the confusion.

I can advise that your request is now closed. If you would like to exercise your right to request a review of the Ministry's decision on your request, you may do so by completing a "Request for Review" form and forwarding it to the Saskatchewan Information and Privacy Commissioner within one year of this notice.

Please find enclosed my Form B Request for Review of the response of the Ministry of Education (the "Ministry") to my freedom of information request, which was sent by letter dated August 11, 2022 (the "FIPPA Request").

In relation to the FIPPA Request, a prior Request for Review had been made by electronic mail on December 12, 2022 in relation to the timing of the response by the Ministry to the *FIPPA* Request. That review resulted in Review Report 247-2022. To be clear, the enclosed Request for Review is **not** with respect to the timing of the response to the *FIPPA Request* by the Ministry which was subject to review by the Office of the Information and Privacy Commissioner, which had been addressed in Review Report 247-2022.

The Ministry disclosed a number of records in the course of responding to the *FIPPA* Request, with the final tranche received March 25, 2024. The Ministry delivered its final section 7 response by letter dated March 28, 2024.

The records disclosed by the Ministry contain numerous redactions, primarily asserting that the redacted information is personal information. The redactions plainly include significant:

- 1. business card information, as that term has consistently been applied in Review Reports of the Information and Privacy Commissioner; and
- 2. license, permit or other similar discretionary benefit granted information within the meaning of *The Freedom of Information and Protection of Privacy Act*, SS 1990-91 c F-22.01 (the "*Act*").

While these examples are specifically identified, these are not the only instances of redactions improperly applied by the Ministry.

I appreciate the Ministry seeking out a convenient method of delivering records by file download through the Government of Saskatchewan Electronic File Transfer Service. In view of the volume of records, this was practical, reasonable, and responsible. I note, however, that in scanning dated records the Ministry has not utilized optical character recognition (OCR) to scan documents into a format that is readily electronically searchable. Use of OCR to scan paper records advances the objectives and purposes of the *Act*. OCR in document scanning equipment is readily available computer hardware and software, would not unreasonably interfere with operation of the Ministry, and is practicable.

Also enclosed with this letter is a USB key containing a number of documents necessary to conduct a review. Those records include:

- 1. Form A Access to Information Request;
- 2. Letter from Edmonson to Duncan, dated August 11, 2022;
- 3. A directory for each of the batches disclosed by the Ministry, along with the letter accompanying the disclosure, as provided by the Ministry;
- 4. Letter from Scharfstein to Cockrill, dated September 13, 2023;
- 5. Letter from Biden to Scharfstein, dated September 22, 2023;
- 6. E-mail from Edmondson to Freedom of Information Requests ED, dated March 22, 2024; and
- 7. Letter from Campbell to Edmondson, dated March 28, 2024.

It is my understanding that there is no batch 27, and that the numbering was as a result of an internal process. If, however, there is a batch 27 in the possession of the Ministry, it has not been delivered.
