AFFIDAVIT OF VICKI STRICKLAND


I, Vicki Strickland, of the City of Regina in the Province of Saskatchewan, MAKE OATH
AND SAY THAT:

1. I am employed as a Legal Assistant with the Civil Law Branch of the Ministry of Justice and Attorney General. I have personal knowledge of the facts herein deposed, except where stated to be on information and belief, and where so stated I do verily believe the same to be true.
2. I have reviewed the Affidavit of Bryan Reynolds, sworn November 1, 2024, and filed in support of the application of Mile Two Church Inc. ("**Mile Two**") to stay the within action as against Mile Two (the "**Reynolds Affidavit**").

3. I have reviewed the Affidavit of Caitlin Erickson, sworn on October 3, 2024 (the “**Erickson Affidavit**”).
4. At paragraph 4 of the Reynolds Affidavit and paragraph 13 of the Erickson Affidavit, the affiants indicate that Plaintiffs’ counsel delivered copies of the Notices of Discontinuance of Stephanie Case, Fran Thevenot, and Tracey Johnson to counsel for Mile Two on or about March 7, 2024. I am advised by Justin Stevenson, Crown Counsel for the Government of Saskatchewan, and verily believe to be true, that Plaintiffs’ counsel has never served copies of these Notices of Discontinuance on the Government of Saskatchewan.
5. As per paragraphs 7 - 11 and Exhibits F, G, H, and I of the Reynolds Affidavit, I am advised by Mr. Stevenson, and verily believe to be true, that on or April 8, 2024, he was copied on this email from Plaintiffs’ counsel, in which the settlement agreements entered into by the Plaintiffs and Stephanie Case, Fran Thevenot, and Tracey Johnson respectively were attached (the “**Settlement Agreements**”).
6. I am advised by Mr. Stevenson, and verily believe to be true, that this was the first time the Plaintiffs advised the Government of Saskatchewan of the existence of the Settlement Agreements and provided same to them.
7. I make this Affidavit in support of the application of the Government of Saskatchewan for an Order dismissing the within action as against the Government of Saskatchewan and for no improper purpose. I swear this Affidavit in compliance with the Law Society of Saskatchewan’s *Code of Professional Conduct*, and state that the matters herein deposed to are uncontroverted and that a lawyer with the Civil Law Branch of the Government of Saskatchewan Ministry of Justice intends to appear as an advocate on this matter.
